#### PRODUCT DESCRIPTION:

This is a paint thinner. Designed to improve the flow of a range of PATSA Coatings epoxy products. Can also be used as cleaner for pumps and tools before and after painting.

#### AREA OF APPLICATION:

Specially suitable as thinner for epoxies and similar type products except Tankguard series. Recommended usage as per technical datasheet or application guide for the specific product to be applied. When thinners are used as a cleaning solvent, the use must be in accordance with prevailing local regulations.
